Ticket of leave holder. Appointed constable 15th December 1826 in the room of Abraham Hunter who resigned.

**Shaw Constable William - 1829 1 January Patterson's Plains SG**

T/L holder. Appointed constable in room of Michael Clarke who was dismissed for drunkenness.

**Shaw Constable William - 1832 15 December Maitland SG**

Witness at the trial of Steel, McGrath, Daley and Ryan. Apprehended McGrath in November 1830.

**Shaw Constable William - 1834 14 June Paterson SG** Resigned from position of Constable.

**Shaw Constable William - 1835 25 April Paterson SG** Appointed constable in place of James Shields.
