Colonial Secretary's correspondence

CS In-letter 34/1218 in 4/2229 Principal Superintendent of Convicts to Col Sec 1 April 1834, have letter from Captain Anley [magistrate at Maitland] seeking approval for his action in withdrawing James Smith per Norfolk, life, from the service of John Eales, having taken the name of Scott, probably his real name, and been transferred by Mr Eales without authority to Thomas Scott of Williams River, alleged brother. Notation: Governor's decision – "the transfer cannot be allowed. The withdrawal is approved".

CSLS 34/226 in 4/3679 Harrington to Hely (Col Sec to Princ Supt Convicts) 21 April 1834, p435 (reel 1047). Re James Smith per Norfolk. Received two letters from the resident Magistrate at Maitland. His Excellency the Governor has approved Smith's withdrawal from Mr Eales' employ because Smith had taken the name of Scott (supposed to be his real one) and been transferred by Mr Eales without authority to one Thomas Scott, the prisoner's alleged brother.
